MARKET COMMENTARY

US indices closed lower on the last trading day of 2025 (31/12); DJIA (-0.63%), S&P 500 (-0.74%) and IXIC (-0.76%), dragged down by semiconductor stocks and heightened market concerns after the Fed released the minutes of its Dec'25 policy meeting, which revealed deep divisions among policymakers over the path of interest rates in 2026. In a summary, the market' last trading day in 2025 largely driven by technical factors, policy expectations and year-end portfolio adjustments. While, the economic data releases remain sparse in the holiday-shortened week. Thus, both USD index and US 10-Y bond yield closed slightly up to 98.32, and 4.17%, last Wednesday.

In Europe, with a shorter trading session on the last trading day in 2025, the STOXX 600 ended slightly lower (-0.10%) as trading was subdued ahead of the New Year holiday. Yet, the STOXX 600 still posted roughly 16.7% gains for the year, its best yearly performance since 2021. On commodity, both Brent crude futures and US WTI were down to USD60.85 per barrel and USD57.42 per barrel, respectively last Wednesday due to the market' rising concern of supply surplus amid subdued geopolitical conditions.

Indices in Asia closed mixed on the last trading day of 2025. While, JCI closed sideways (+0.03%), but with IDR937.79 bn net foreign outflow. Today, the JCI could close lower due to a rebound in USD and global oil prices, despite more subdued geopolitical conditions.

TPIA - Completes Esso-branded fuel station acquisition in Singapore

Chandra Asri Pacific (TPIA) has completed the acquisition of the Essobranded fuel station network in Singapore as of 1 Jan 2026, marking a key milestone in its strategy to build an integrated energy infrastructure platform. Previously, to support the transaction, sister company Chandra Daya Investasi (CDIA) extended a USD95 mn (around IDR1.59 tn) loan to Chandra Asri Capital Pte. Ltd. (CAC), a TPIA subsidiary, to support this transaction. (Source: Company)

PJAA - Secured IDR100 bn credit facility

Pembangunan Jaya Ancol (PJAA) has secured a credit facility of IDR100 bn from Bank Danamon, which is part of a guaranteed acceptance credit facility totaling IDR200 bn, on September 18, 2025. PJAA and Bank Danamon have also entered into a sight/usance letter of credit (L/C) agreement worth IDR20 bn. (Source: Emiten News)

SHIP - Acquired new fleet worth IDR1.34 tn

Silo Maritime (SHIP) through its subsidiary, Cassa Mega Lautan, has acquired a new fleet in the form of a gas carrier ferry vessel worth IDR1.34 tn from New Gas Taurus. The vessel has a length of 217 meters, a beam of 36.6 meters, a depth of 18.6 meters, a length overall (LOA) of 226 meters, and a net tonnage of 18,825. (Source: Emiten News)

WMPP - Targets revenue growth in 2026

Widodo Makmur Perkasa (WMPP) targets revenue to double in 2026, supported by higher national meat consumption and the government's Makan Bergizi Gratis (MBG) program. Management expects additional demand from MBG to support volume growth across beef and poultry, while recent performance has improved following the completion of the PKPU process. In 9M25, revenue rose 87.2% YoY, driven mainly by the poultry segment. (Source: Kontan)

ECII - Holds promotional sales event at Big Bang Festival 2025

Electronic City Indonesia (ECII) is participating in the Big Bang Festival Jakarta 2025, offering large-scale discounts and promotional programs across electronics, home appliances, and gadgets. Management aims to boost year-end sales through aggressive pricing, bank promotions, and event-driven traffic during the peak holiday period. The update is operational in nature, with no specific revenue or earnings guidance disclosed. (Source: Kontan)

KLBF - Growth strategy across all business lines

Kalbe Farma (KLBF) is targeting growth across its prescription drugs, health products, nutrition, as well as distribution and logistics segments, with a focus on product innovation and strengthening collaboration with strategic partners. KLBF is also ensuring sufficient production capacity and mitigating foreign exchange volatility, particularly as some raw materials in the nutrition segment are still denominated in U.S. dollars. On the other hand, several medical device projects are nearing completion, including X-ray and dialyzer products, which have already entered the production phase, while the CT scan project is still under development in collaboration with GE Healthcare. UNTR - Faces near-term pressure from weather and weak coal prices

United Tractors (UNTR) recorded weaker performance amid operational disruptions caused by flooding and landslides in Sumatra, alongside continued pressure from low coal prices. These conditions have weighed on mining activity and are expected to soften demand for heavy equipment going into 2026, despite support from backlog and business diversification. Overall, the update reflects near-term challenges, with sentiment remaining cautious due to commodity and operational risks. (Source: Kontan)

INDF - Rising wheat prices weigh on margins

Indofood CBP Sukses Makmur (INDF) faces margin pressure amid rising global wheat prices toward the end of 2025. Higher raw material costs have led to weaker near-term margin expectations, particularly in the instant noodle segment, despite stable sales growth. The update reflects cost-side pressure, while longer-term fundamentals remain supported by strong brand positioning and agribusiness contributions. (Source: Bisnis Indonesia)
